Am I eligible?

You may be entitled to a rates rebate as an owner of a company-share or 'owner-occupier' flat if you meet all 4 criteria listed below.

Criteria 1: you live in a residential flat.

Criteria 2: your right to occupy the flat is because, you are either:

- the owner of an estate or have an interest in the land on which the building comprising or including the owner-occupier flat is erected, or
- a shareholder of a company which owns the land on which the building comprising or including the owner-occupier flat is erected.

Criteria 3: you are required to pay rates either pursuant to a written agreement:

- · entered into prior to taking possession of the flat, or
- made by a previous occupant and binding on the present owner-occupier.

Criteria 4: you paid rates for the home you lived in on 1 July.
