



RATES REBATE DECLARATION FORM

for an owner of an "owner-occupier" flat

You may be entitled to a rates rebate as an 'owner-occupier' if you:	
Live in a residential flat;	AND
Your right to occupy the flat is because, you are either <ul style="list-style-type: none"> the owner of an estate or interest in the land on which the building comprising or including the owner-occupier flat is erected; OR a shareholder of a company which owns the land on which the building comprising or including the owner-occupier flat is erected; 	AND
You are required to pay rates either <ul style="list-style-type: none"> pursuant to a written agreement entered into prior to taking possession of the flat; OR pursuant to a written agreement made by a previous occupant and binding on the present owner-occupier; 	AND
You paid rates for the home you lived in on 1 July.	

If you fit the above criteria then please complete the sections below.
