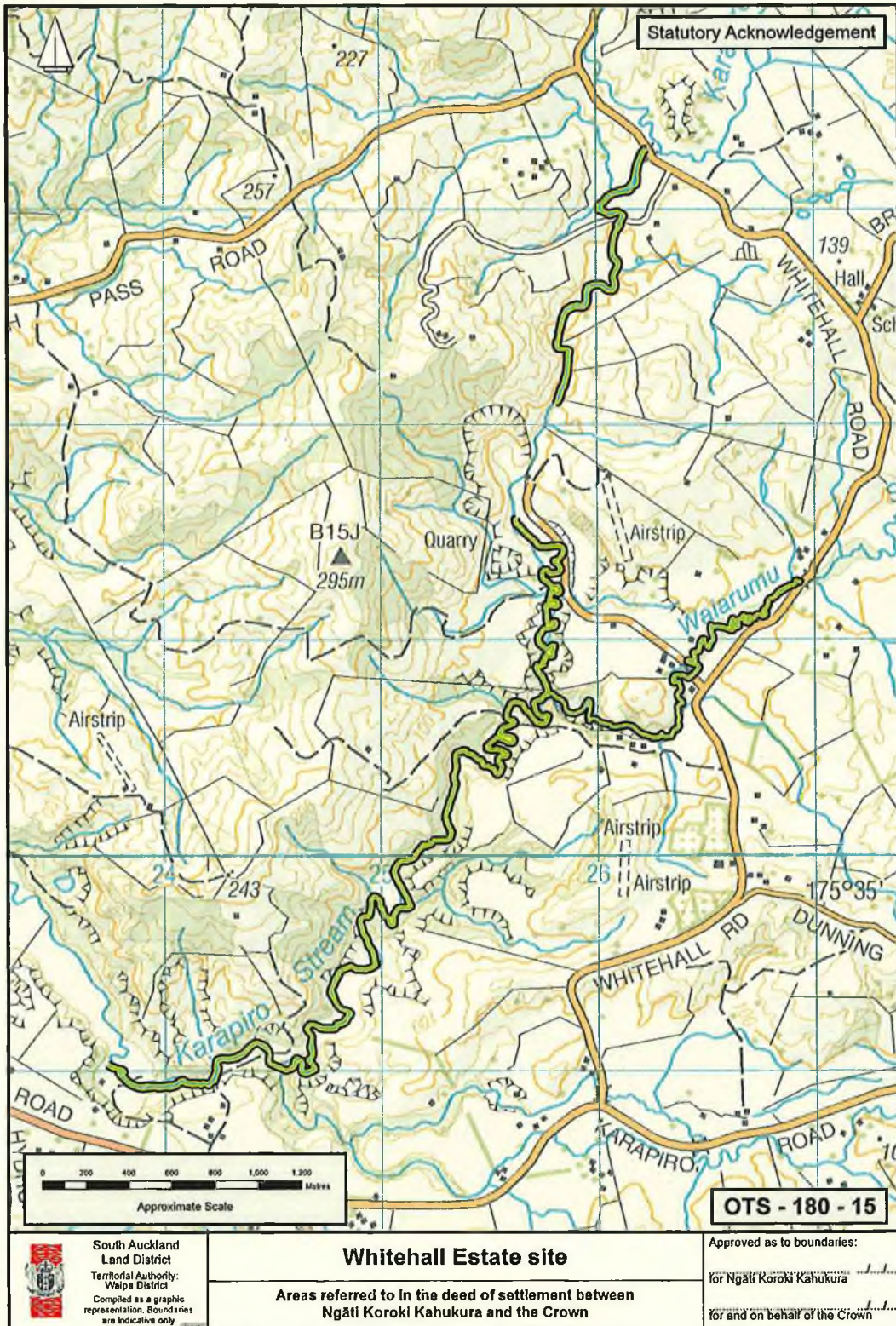

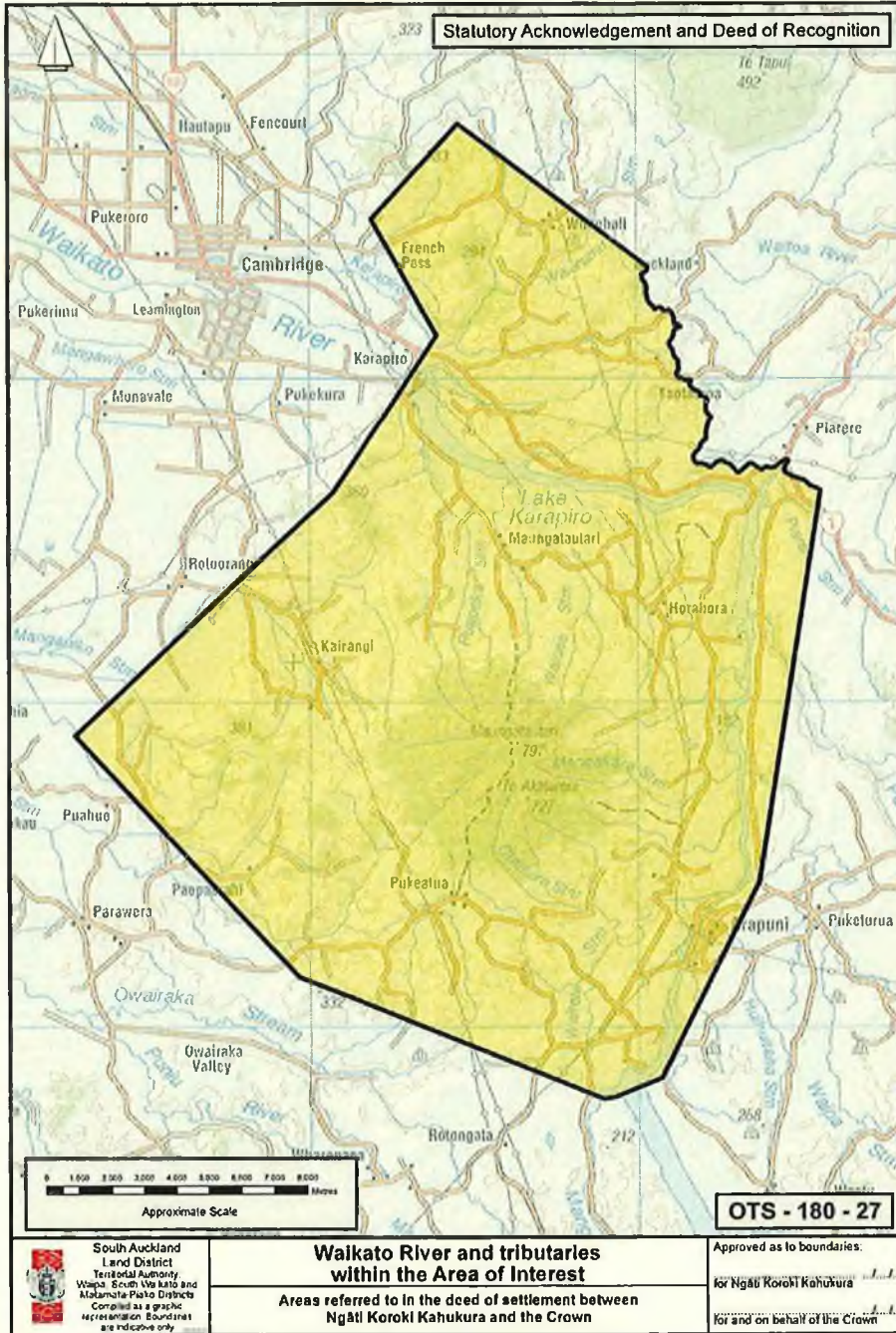
PŌKAIWHENUA STREAM MARGINAL STRIP SITE (OTS-180-17)

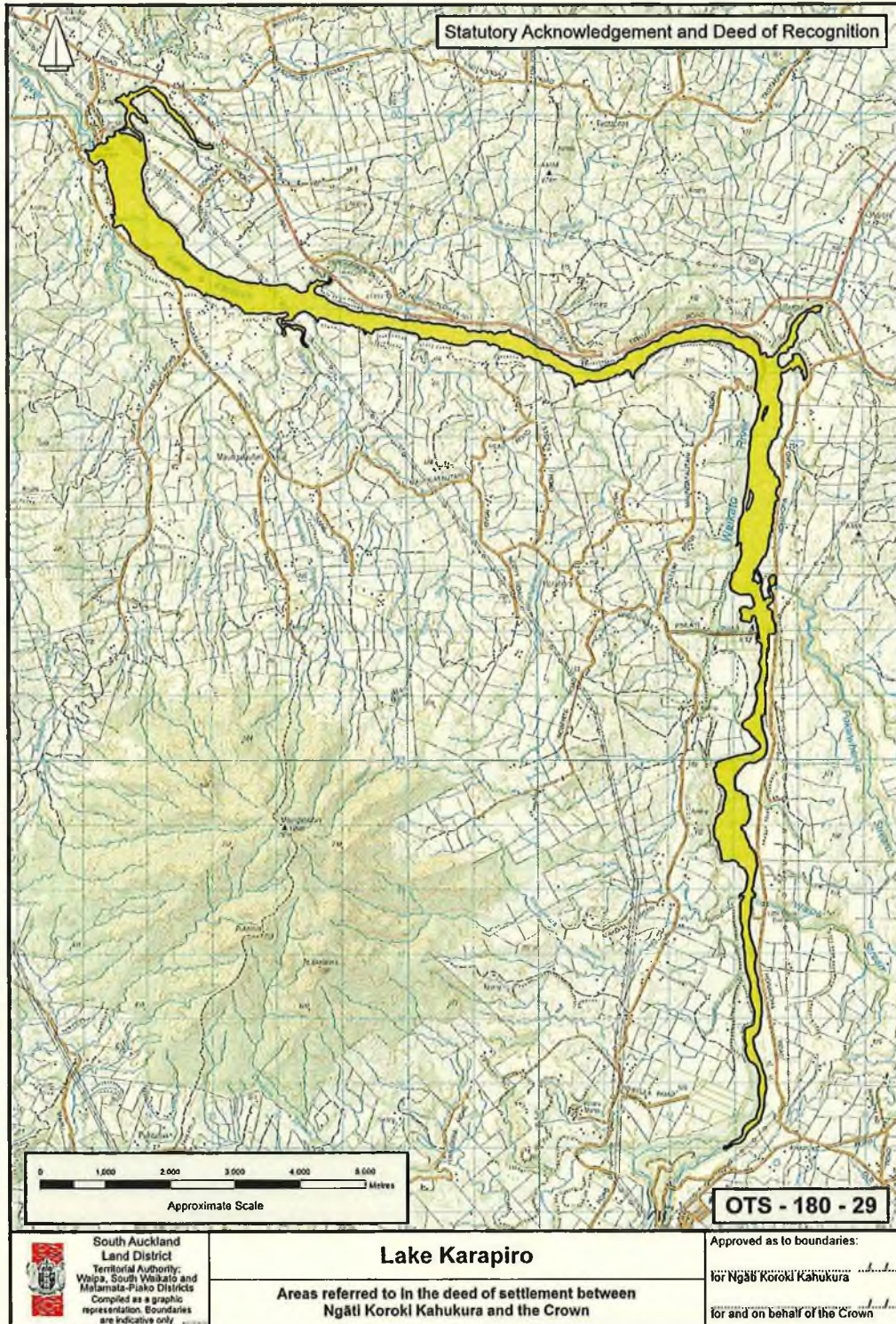
