### Before you apply

### To be eligible for a grant of citizenship, you must meet the following criteria:

- You are entitled to reside indefinitely in New Zealand; AND you have been present in New Zealand:
  - for at least 1,350 days with New Zealand residence during the 5 years immediately before you make your application; and
  - for at least 240 days with New Zealand residence in each of those 5 years; and
  - fully met any and all residence conditions imposed by Immigration New Zealand (INZ).
- · You are of good character.
- You understand the responsibilities and privileges of New Zealand citizenship.
- · You are able to hold a basic conversation in English.
- You intend to continue living in New Zealand, if granted citizenship.

'New Zealand residence' means you have a current residence permit, permanent residence visa or residence visa issued by INZ, you are an Australian citizen or permanent resident, or you are a New Zealand citizen by descent.

### What you need to complete this application

- · Your original birth certificate or your country's equivalent document.
- Your current passport(s) or most recent passport if it has expired.
- 2 identical colour photos of yourself that are less than 6 months old. We recommend you have your photos taken by a business that offers a passport photo service. These businesses can ensure your photos meet our requirements. Do not staple, glue or paper-clip photos to this application as this damages the photos.
- A person who can act as a witness for you. They must complete Section 10: Witness section.
- Evidence that you can speak English in everyday situations, if it is not your first language.
- The application fee of \$470.20 per adult aged 16 years or over.

We do not accept photocopies.

If you are living as a different gender than what appears on your birth record, passport or travel document, you must provide a statutory declaration with this application that states:

- the gender you want on your citizenship certificate (male, female or non-binary)
- how long you have been living with that gender identity.

Make sure the information you provide is true and correct. All questions must be answered. If you need

more space to answer a question, use another piece of paper. If it is later found that you have provided false or misleading information, you may be denied citizenship or lose citizenship once it is granted, or face criminal charges, or both.

#### Withdrawals and refunds

If you do not meet the requirements for citizenship, you can withdraw the application and get a partial refund of your application fee. Part of the fee is kept to cover the costs of the initial processing of your application.

In order to process your citizenship application, we will need to collect some personal information from you. The decision to give us your information is your choice. If you do not give us all the information we need, we may decline your application.

We need your information to:

- · verify your identity, and
- assist the Minister of Internal Affairs to decide whether you qualify for a grant of New Zealand citizenship.

We collect and hold information from this form at the Department of Internal Affairs, PO Box 10680, Wellington. Under the Privacy Act 2020 you can request access to and correction of the personal information we hold about you.

The information collected in your application may be used in statistical analysis and reporting for service improvement and business management purposes. Personal information will only be used where necessary for those purposes.

Data is stored, accessed and retained in accordance with our Privacy Policy, Information Management Policy, and the DIA Code of Conduct which incorporates our ICT and security policies, and in compliance with the Privacy Act

2020 and the Public Records Act 2005.

#### Information sharing

The Department of Internal Affairs (DIA) relies on the Identity Services Approved Information Sharing Agreement (IS AISA) to access information relating to your birth, death, marriage, name change, civil union and passport when verifying your identity.

DIA relies on the Customer Nominated Services Approved Information Sharing Agreement (CNS AISA) to share information with Immigration New Zealand (INZ) to verify your identity and confirm eligibility requirements are met for a grant of New Zealand citizenship.

DIA may share your citizenship information once you have been granted citizenship with other government agencies. Full details of the DIA's information-sharing practices are available on our website: dia.govt.nz/Legal-Privacy-Index.

Your photo will be used to help confirm your identity. This includes matching it with photos held in immigration records from the Ministry of Business, Innovation and Employment, and searching the Department's passport database. These checks help protect your identity and detect fraud.


